WE WHO ARE

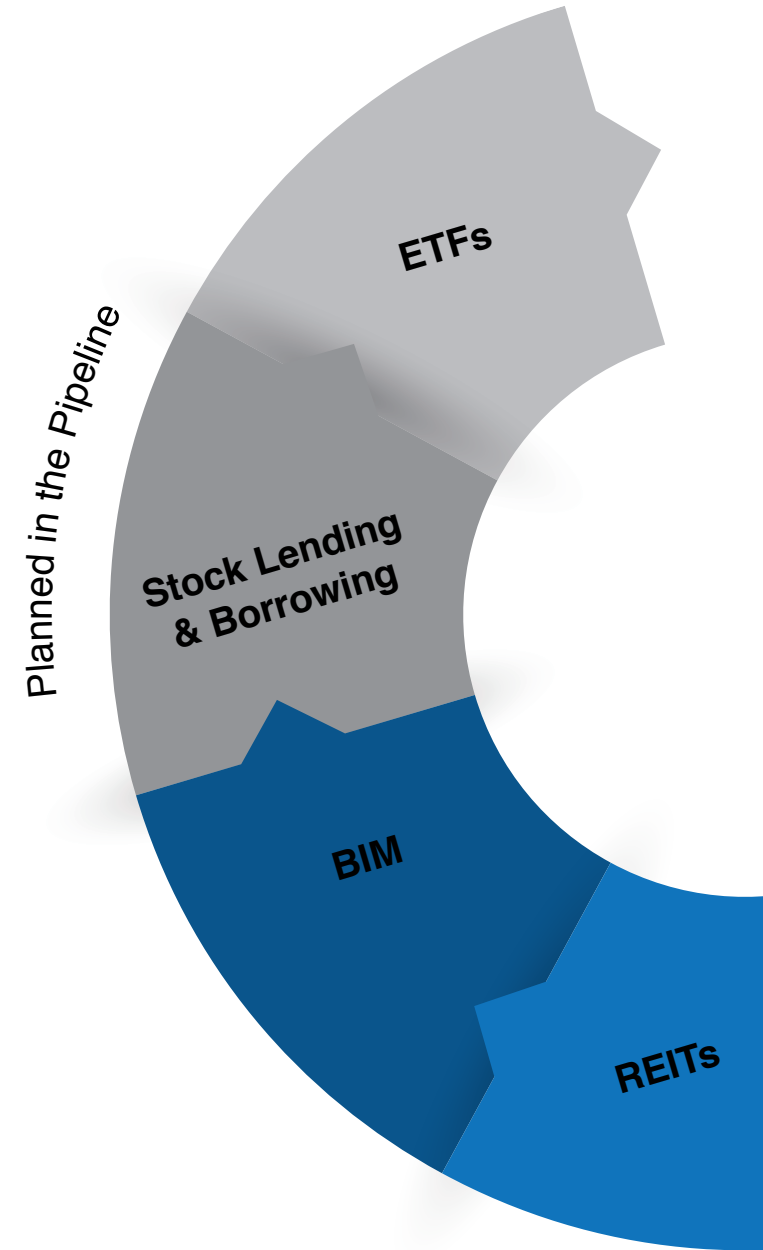
