

## **Announcement Regarding Nomination for Board Membership**

The election process will be carried out during the upcoming Ordinary General Meeting scheduled to be held on Thursday, 30 September 2021.

## **Conditions for Nominations:**

## Candidates must:

- 1. have full legal competence to act.
- 2. not have previously been convicted of default bankruptcy, fraud, offences relating to his honour or integrity or of an offence under the Commercial Companies Law, unless subsequently reinstated.
- 3. not prohibited from being a member of the Board of Directors of a joint stock company in accordance with the provisions of any laws enforced in the Kingdom of Bahrain.
- 4. be experienced and competent for membership of the Board of Directors in accordance with the requirements stipulated in the Articles of Association of the Bank, the Bahrain Commercial Companies Law, the Central Bank of Bahrain (CBB) Rules and any other requirements, determined from time to time, by the CBB or any governmental or regulatory body.

Nominations are subject to approval by the CBB.

## **Required Documents:**

- 1. A signed completed CBB Form 3 Application for Approved Person Status, which can be downloaded from the CBB's website (<u>Link</u>) (the "**Application Form**"), together with all of the required information and documents specified in the Application Form.
- 2. Details of existing relationships between the candidate and the Bank (including ownership therein), and the candidate and the other approved persons of the Bank, pursuant to the requirements of the Application Form.
- 3. Certified copies of the candidate's passport and ID.
- 4. An updated copy of the professional profile of the candidate /representative.
